- To help you meet your educational expenses, Purdue University North Central is pleased to offer Nelnet Business Solutions as a convenient budget plan. It is not a loan; therefore you have no debt, there are no interest or finance charges assessed and there is no credit check.
- The cost to budget monthly payments is a **\$25 per semester nonrefundable enrollment fee**. The enrollment fee is automatically deducted from your account WITHIN 14 days of your agreement being posted to the system.
- The tuition payment is automatically deducted on the 5th of each month from a checking or savings account. You may also have your payment charged to your credit card. If you elect to use your credit card, only VISA, MasterCard, American Express, or Discover Card may be used. Please note: Debit Cards may be returned unpaid due to daily limit restrictions imposed by your bank.
- If your payment on the 5th is not successful, it will be reattempted on the 20th of the month. Any time a payment is returned, you will receive notification on how the returned payment will be handled. Your agreement will be processed until the balance owed is paid in full.
- For each returned payment, you will be assessed a \$25 returned payment fee. Please note, your financial institution may also assess you a fee. Returned payment fees are automatically deducted from the account you have provided. If your returned payment fee is returned, it will be reattempted. Returned payment fees are payable to Nelnet Business Solutions/FACTS.
- Enrollment fees and returned payment fees are subject to change in future academic years or semesters. Interest earned on all custodial funds held by Nelnet Business Solutions/FACTS is payable to Nelnet Business Solutions/FACTS.

## Completing the FACTS Agreement

When you apply online be sure to have the following information:

- Five or six-digit student ID number as assigned by Purdue University North Central.
- The name and address of the person responsible for making the payments.
- Account Information for the responsible person.
  1. If paying by automatic bank payments, you will need the financial institution's name, telephone number, account number, and the financial institution's routing number. Most of this information is located on your check.
  2. If paying by credit card, you will need the credit card number and expiration date.

Enrolling online is simple, secure, and easy. Connect to the e-Cashier Web site through [www.pnc.edu](http://www.pnc.edu). Under Students, Faculty & Staff, select Bursar, click on Payments, Refunds and Deadlines. Under FACTS Payment Plan, you can download the current bookmark giving you full details on how the plan works. Click on FACTS Payment Plan to enroll in the plan. Or you can connect to My PNC through [www.pnc.edu](http://www.pnc.edu). Once you are in My PNC, choose the Pay Online option, then select the FACTS Payment Plan Option.

The payment plan can accommodate down payments and monthly payments. Before you click the Submit button, please read carefully through the Final Review and the Terms and Conditions. An immediate e-mail will be sent (if an e-mail address was provided for the person responsible for payment) confirming enrollment through e-Cashier.

## IMPORTANT!

If you have questions about your agreement or need to make a change to your address, phone or account number, please call Nelnet Business Solutions/FACTS at 800.609.8056. Please be sure to have your agreement number and access code available before placing the call.

Please do not assume your balance will automatically be adjusted if financial aid is received or a class is dropped or added. You should review your agreement balance online through My FACTS Account or call the Purdue University North Central Bursar's Office at 219.785.5337 to confirm the change.

### Summer 2 (8-week) Session 2008

*e-Cashier available on March 17, 2008.*

Last day to enroll online	Required down payment	Number of payments	Months of payments
May 22	40%	2	June & July
June 13	50%	1	July only
