

2008-2009 Verification Worksheet - INDEPENDENT

Your application was selected for review in a process called "Verification." The law says we have the right to ask you for this information before awarding Federal aid. If there are differences between your application information and your financial documents, Purdue North Central may need to make corrections, which will be done electronically.

Complete this verification form and submit it to the Financial Aid Office along with copies of your Federal tax returns(s) and W-2 form(s) as soon as possible so that your financial aid won't be delayed.

What you should do

1. Collect and copy your (and your spouse's, if you are married) financial documents (signed Federal income tax forms, W-2 forms, etc.)
2. Complete and sign this Verification Worksheet.
3. Submit the completed Verification Worksheet, Federal tax form(s), W-2 form(s) and any other documents requested to the Financial Aid Office. Purdue North Central must review the requested information under the financial program rules (34CFR, Part 668).
